Sachverhalt

- The host institution must undertake to bear the costs incurred by public bodies up to 6 months after the end of the internship agreement for living expenses of the person from abroad during an unauthorized stay in Germany and deportation
- Internship must be equivalent in terms of subject and level to the course of study or university degree
- It is not possible to take up employment during the stay
- Temporary residence permit for the agreed duration of the internship, but for a maximum of 6 months
- Minors require the consent of a person entitled to personal care if they plan to stay for the purpose of a study-related internship
- A fee is payable for the issue of the residence permit; the time and form of payment vary depending on the authority
