Teaser	If you have a temporary permit to operate a prostitution business and wish to extend it, you must apply to the competent authority.
Volltext	If you operate a prostitution business, including prostitution establishments, prostitution agencies, prostitution vehicles or prostitution events, and your permit is valid for a limited period, you can apply to have it extended. The condition is that your business fulfills the relevant requirements. Operating a prostitution business without a valid permit is an administrative offense. You should therefore apply for an extension in good time.
