Volltext	You require a permit for the commercial transportation of passengers in rental cars. You can submit a corresponding application to the transport authority responsible for you in the respective independent city or district.
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Formal application (surname, first name of the applicant; place of residence and business; in the case of natural persons, date and place of birth; number of vehicles, vehicle type, capacity of the vehicles to be used) • Certificates of employment or examination certificates (for professional suitability) of the applicant or the person appointed to manage the business • Equity certificate / additional certificate (form in accordance with Section 2 (2) No. 2 / Section 2 (3) of the Professional Access Ordinance for Road Passenger Transport -PBZugV), not older than 3 months • Clearance certificate from the tax office, the municipality, the social insurance institution and the employers' liability insurance association, not older than 3 months (from the company, the legal representative and the person appointed to manage the business / transport management) • Certificate of good conduct for submission to the authorities in accordance with Section 30 (5) BZRG • Extract from the central trade register in accordance with Section 150 (5) GewO (for companies)
