Teaser	If you want to use a main road in a local thoroughfare in a way that goes beyond its intended purpose, you must apply for a special use permit.
Volltext	<p>Public roads, paths or squares are dedicated to public use. This means that these areas are accessible to you and any other person and can be used by the general public without the need for special permits or restrictions.</p> <p>If you intend to do something that goes beyond public use, you may need a permit for this special use, known as a special use permit. You must apply for the special use permit from the responsible authority.</p> <p>The requirements for special use within a locality may be different from the requirements for special use outside a locality.</p> <p>For this reason, the requirements regarding parking, traffic regulation, the operation of street cafés and road construction work, for example, are generally more extensive than the requirements for special use outside a locality.</p> <p>The requirements may vary depending on the location. The responsible authority can inform you accordingly upon request.</p> <p>Note: If you require a permit for excessive road use in accordance with the Road Traffic Act, the special use</p>

Hinweise	<p>The following information is available:</p> <p>Even if all factual and legal requirements are met, you are not entitled to be granted a special use permit. The competent authority decides on your application at its own discretion.</p> <p>As a rule, the competent authority will grant you the special use permit for a limited period and subject to revocation. This means that the permit issued can be withdrawn. The permit is usually issued with conditions that you must fulfill.</p> <p>The competent authority may require you to pay for the removal of any damage caused by your special use. The competent authority may also require you to make an advance payment or deposit a sum of money as security.</p>
