Teaser	If you want to drive trucks, you must have your driver's license extended by class C, CE, C1 or C1E at the driver's license authority. These extended driving license classes are limited to 5 years.
Volltext	To drive trucks or vehicle combinations consisting of a truck and a trailer, you need an extended driver's license for class C, CE, C1 or C1E. You can apply for the extension of your driver's license at the driver's license office in your place of residence. When you apply for an extended driver's license for classes C, CE, C1, or C1E, the license is issued for a limited period of 5 years. You must apply for an extension before the expiry date.
	Depending on the class, the extended driver's license entitles you to drive various trucks or vehicle combinations consisting of a truck and a trailer. To apply for the extension, you must meet various requirements.
	Class C driver's license:
	<ul> <li>Motor vehicles with more than 3.5t total weight and a maximum of 8 seats except the driver's seat</li> <li>trailers with up to 750kg total weight</li> <li>required driving license: class B</li> <li>Minimum age: 21 years, or 18 years if you drive trucks professionally</li> </ul>
	Driving license class CE:
	<ul> <li>Motor vehicles with more than 3.5t total weight and a maximum of 8 seats except the driver's seat</li> <li>trailers with more than 750kg total weight</li> <li>required driving license: class C</li> <li>Minimum age: 21 years, or 18 years if you are a professional truck driver.</li> </ul>

	<ul> <li>driving license class C1:</li> <li>light commercial vehicles with between 3.5t and 7.5t total weight and a maximum of 8 seats except the driver's seat</li> <li>trailers with up to 750kg total weight</li> <li>required driving license: class B</li> <li>minimum age: 18 years</li> <li>driving license class C1E:</li> <li>light commercial vehicles with between 3.5t and 7.5t total weight and a maximum of 8 seats except the driver's seat</li> <li>trailers with more than 750kg total weight, maximum as heavy as the unladen weight of the towing vehicle</li> <li>maximum total weight of the combination of 12t</li> </ul>
Erforderliche Unterlagen	<ul> <li>required driving license: class C1</li> <li>minimum age: 18 years</li> <li>Identity card or passport with current registration certificateCurrent biometric photo (size 45x35 mm, portrait format, frontal)</li> <li>Eye test certificate (not older than 2 years)</li> <li>Proof of physical and mental fitness (not older than 1 year)</li> <li>current driving license</li> <li>Information about the driving school</li> </ul>
Voraussetzungen	<ul> <li>Your main place of residence is in Germany.</li> <li>You have a driver's license with the respective required class.</li> <li>You have reached the minimum age for the respective class when the driver's license is issued.</li> <li>You can submit your application at the earliest 6 months before reaching the minimum age.</li> <li>You are qualified to drive a truck.</li> <li>You have successfully completed the theoretical and practical training and examination required in the class applied for to drive a truck.</li> </ul>

Kurztext	<ul> <li>Driving license with limited period of validity Extension by classes C, C1, CE or C1E</li> <li>an already existing driving license can be extended by further driving license classes (colloquially "truck class")</li> <li>the respective C class entitles the holder to drive different trucks</li> <li>Depending on the C class, different requirements are necessary</li> <li>driving license limited to 5 years</li> <li>responsible: competent driving license authority</li> </ul>
