The personal PIN number is sent to the responsible specialist at his or her home address. Specialists may only have one workshop card per employment relationship and may only use it there. The workshop card is the property of the company.</p> <p>The workshop card is valid for 1 year from the date of personalization by the Kraftfahrt-Bundesamt (KBA). - You can apply for entrepreneurs or persons authorized to represent the company or persons with power of attorney
- Workshop card is tachograph card for approved manufacturers of tachographs, vehicle manufacturers, workshops as well as their responsible specialists (installers)
- Workshop card is used by specialists to install, check and calibrate digital tachographs and download their data
- Workshop card is PIN-protected personal PIN number is sent to the employee's home address
- Skilled workers may only have one workshop card per employment relationship and may only use it there
- Workshop card is valid for 1 year
- Responsible: different authorities depending on the federal state, e.g. driving license authority, TÜV, Dekra or others
