## Verfahrensablauf

If you want to use the single point of contact service, you must contact the single point of contact in the federal state in which you want to carry out your project:

- Go to the website of the single point of contact for the federal state relevant to you.
- There you can determine the administrative procedures required for your project. Search functions and/or electronic assistants are usually available for this purpose.
- You will then be directed to the relevant online procedures.
