Teaser	If your earning capacity is reduced by less than 40 percent, you can apply for a monetary sum as a settlement for life instead of an accident pension.
Volltext	Is your earning capacity permanently reduced by less than 40 percent? Then you can apply for a settlement of the current pension. How the settlement amount is calculated is regulated in a legal ordinance. Among other things, your age at the time of the accident and the time that has passed since the accident play a role here. With a settlement, your pension entitlement then expires in principle for life. If you are entitled to several pensions with a combined reduction in earning capacity of less than 40 percent, all or only some of them can be settled. If your health condition worsens later as a result of the insured event, your pension entitlement may be revived for this part of the worsening.
Erforderliche Unterlagen	You do not need to submit any documents.
Voraussetzungen	You are entitled to a pension settlement if: • you are receiving a pension for an indefinite period after a reduction in earning capacity of less than 40

	percent, • your reduction in earning capacity is not expected to decrease significantly within the settlement period, • you have enough income to live on without the pension, • you submit an application for severance pay.
Kosten	There are no costs involved.
Verfahrensablauf	You can apply for settlement of an accident insurance pension for a reduction in earning capacity of less than 40 percent is online or by mail. Online service: • Access the online service. • You will be guided through the process on the Accident Insurance Service Portal. • You can log in. If you would like to receive the response from your workers' compensation association or accident insurance fund in the mailbox of your BundID account or My Business Account, you must have an account and authenticate. If you would like to receive the answer by mail, you can also proceed without logging in. • Select your responsible employers' liability insurance association or accident insurance fund or determine it using the industry search. • Upload the required documents. • Fill out the online form and submit it. • Your report will be automatically forwarded to your employers' liability insurance association or accident insurance fund. • You will receive a response via the requested channel. Online service of your employers' liability insurance association or accident insurance fund: • If you have access to the portal of your employers' liability insurance association or accident insurance fund, you can also submit the notification electronically there, if necessary. Rechtsbehelf	• Opposition. Detailed information on how to lodge an appeal can be found in the notification from your employers' liability insurance association or accident insurance fund.
Kurztext	• Settlement of a pension for persons insured under the statutory accident insurance scheme in the event of a reduction in earning capacity of less than 40%. • current pension due to consequences of accident or occupational disease may be settled with a lump-sum payment • in the case of a pension due to reduced earning capacity below 40 percent, only a few conditions must be met • a settlement is not possible if no pension is paid for an indefinite period, i.e. the payment is limited in time in the decision and/or there is no permanent condition, i.e. it is to be expected that the health condition will not be permanent • the amount of the settlement sum is determined by the capital value, the calculation of which is determined by the Federal Government by statutory order with the consent of the Bundesrat (Upper House of Parliament) • The capital value is determined, among other things, by the number of years of life completed at the time of the accident and by the time that has elapsed since the accident. • Costs: none • Processing time: none
