Teaser	Foreign nationals who have received a residence permit for the purpose of employment as former tolerated persons can apply for the extension of their temporary residence permit.
Volltext	You can apply for the extension of your residence permit for qualified tolerated persons issued for the purpose of employment if you want to continue to pursue employment and continue to meet the other requirements. In principle, the same conditions must be met for the extension of the residence permit as when it was first issued. In particular, you must be able to secure your livelihood and health insurance cover from your own resources without recourse to public benefits. To process your application, the Foreigners' Registration Office usually involves the Federal Employment Agency, which checks the working

	conditions. After two years of holding the residence permit and if during this period an occupation corresponding to the professional qualification has been exercised, access to the labour market is no longer subject to any restrictions.
	In the event of an extension, your residence permit will be limited again. As a rule, the residence permit cannot be extended if this was already excluded when the residence permit was issued or last extended.
Erforderliche Unterlagen	In principle, the extension of your residence permit requires the presentation of the same documents as for the first issue:
	 Recognized and valid identity document (for example, passport or passport substitute) Current biometric photo in passport format (45 x 35 mm) Proof of completed training (e.g. university degree, certificates of completed vocational training) For foreign university degrees: Notification of recognition or comparability of the university degree, if available Certificate evaluation of the Central Office for Foreign Education (ZAB), if available Employment contract or the "Declaration of employment" form completed and signed by the employer (see forms). Proof of previous activities (e.g. employment references, employment contracts), if available Proof of German language skills Proof of securing one's livelihood (e.g. equity, blocked account, declaration certificate In individual cases, the Foreigners' Registration Office may require less or further proof.
Voraussetzungen	In principle, you must meet the same requirements for the extension of the residence permit as when the residence permit was issued for the first time, i.e.: • You have a recognized and valid identity document (for example, passport or passport substitute).

	 You have in the Federal territory have completed qualified vocational training in a state-recognised or comparably regulated training occupation or a university degree or with a recognised foreign university degree or a foreign university degree comparable to a German university degree, has been employed for at least two consecutive years in a manner appropriate to his or her degree, or have been in skilled employment for at least three years without interruption and have not been dependent on public funds within the last year (with the exception of benefits to cover the necessary costs of accommodation and heating). You have sufficient German language skills at least at level B1 of the Common European Framework of Reference for Languages. You can submit a specific job offer or a contract (the form "Declaration of employment" serves as proof of the specific job offer). You have sufficient living space for you and your family. The Federal Employment Agency has approved the exercise of employment. You can secure your livelihood and health insurance cover from your own resources without recourse to public services. There is no interest in expulsion against you. Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany
Kosten	The following fees apply: • 96,00 for a further stay of up to three months • 93,00 for a further stay of more than three months

	Additional fees may apply for the issuance of the residence permit in the form of an electronic residence permit, which can also be used as an electronic proof of identity.
Verfahrensablauf	• Find out whether your immigration authority allows you to submit your application online or has a special application form.

	 If the application is only possible in person, make an appointment at the Foreigners' Registration Office. In the case of an online application, the Foreigners' Registration Office will contact you upon receipt of your application to make an appointment. During the appointment, your identity and documents will be checked (please bring your documents, preferably original, to the appointment). If your request is granted, your fingerprints will be taken for the production of a new electronic residence title (eATKarte). The Foreigners' Registration Office commissions Bundesdruckerei to produce the eAT card. After completion, you will receive information and can pick up the residence permit at the responsible office. The eAT card must always be picked up in person. If your application is rejected, you will receive a rejection notice.
Bearbeitungsdauer	About six to eight weeks Note for further information on processing time: The production of the electronic residence title by Bundesdruckerei takes about 4 to 6 weeks.
Frist	Extension of the residence permit: no later than 8 before the expiry of your current residence permit, the application should be received by the Foreigners' Registration Office Opposition period: 1 month

	 qualified tolerated persons for the purpose of employment, prove that the foreign person has sufficient housing, if the foreign person has been in possession of the residence permit for less than two years, is still seeking qualified employment or there is a job offer for further employment corresponding to the professional qualification, if the foreign person has already been in possession of the residence permit for two years, the employment relationship continues or there is another job offer (the residence permit entitles the holder to any employment after two years of employment corresponding to the professional qualification). The local immigration authority usually involves the Federal Employment Agency. The extension of the residence permit is generally limited for the duration of employment, usually for two years.
