Volltext	Anyone who would like to start a restaurant business (serving trolley, beer tent, etc.) at short notice on a special occasion (e.g. folk festival, music event) must notify the competent authority in writing no later than 4 weeks before the start of the event . However, the special occasion must not lie solely in the gastronomic activity itself. In the display are • the surname and forename of the trader with an address capable of being summoned; • the place and period during which the restaurant business was carried on, • the food and drink to be administered, and • the expected number of visitors
