Volltext	As the operator of an evaporative cooling system, a cooling tower or a wet scrubber, you are obliged to inform the competent authority immediately in accordance with Annex 3 Part 1 of the 42nd BImSchV and within a period of 4 weeks in accordance with Annex 3 Part 2 of the 42nd BImSchV if a laboratory test reveals that the measures specified in Annex 1 of the 42nd BImSchV for the concentration of Legionella in industrial water have been exceeded. The competent authority receives the information and examines the measures you have taken.
