Teaser	If your spouse is not the parent of your child and you want them to receive your married name, you can change the child's name.
Volltext	If you have parental authority over a child – alone or jointly with another parent – and your spouse/partner is not the parent of the child, you can give the child you have taken into your common household your married or civil partnership name by declaration to the registry office. You may also prefix or add the married name or civil partnership name to the name the child is using at that time.

Kosten	Fees of 23.50 euros are charged for the certification of the declaration, unless the municipality has set a different fee by statute.
Verfahrensablauf	<p>You can submit the declaration of the name change at any registry office. The declaration becomes effective as soon as it is received by the registry office that keeps the birth register entry for the child.</p> <p>Upon request, you will receive a certificate of the name change.</p> <p>The register of marriages or civil partnerships and the register of births are updated.</p>
