Volltext	If you want to carry out analyses in accordance with the Sewage Sludge Ordinance, you must apply to the competent authority to notify (designate) you as the investigating body. The notification is valid for the entire federal territory.

Please attach the required documents. If necessary, the authority will request further application documents. After verification by the competent body, you will receive a written notification as to whether the notification will be made as an investigating body. The authority may make the notification subject to a reservation of withdrawal, a time limit, conditions, obligations and the reservation of conditions.</p>
<b>Bearbeitungsdauer</b>	<p>The examination of the request for notification of an investigating body must be completed within three months; Section 42a (2) sentences 2 to 4 of the Administrative Procedure Act (Verwaltungsverfahrensgesetz, VwVfG) applies.</p>
