Scientific or technical purposes, testing, assessment or investigation and similar purposes are recognised as reasons. As proof of scientific activity, publications or other proof of specialist knowledge will usually be requested from you. An expert activity is to be separated from a collecting activity. A public law appointment and swearing-in by a Chamber of Crafts is not required of you. The permit is usually issued to you for firearms or ammunition of any kind. |
