| Verfahrensablauf                | Proceed as follows to obtain a renewal of the permit for the commercial transportation of passengers by rental car:  |
|                                 | <ul> <li>Submit a corresponding application to the transport authority responsible for you and enclose all the necessary documents with the application.</li> <li>The authority will process your application and carry out the necessary hearing procedures.</li> <li>You will receive a notification of the decision to reissue the rental car permit. You may receive a certificate of approval.</li> </ul> |
| Bearbeitungsdauer               | The processing time may vary between the competent transport authorities. The processing time may depend, among other things, on whether all documents relevant to the decision have been submitted or whether additional requests for documents are necessary.  |
| Frist                           | Deadlines only start to run when an application is ready for a decision. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary.  |
