After examination, the application is submitted to the State Forestry Committee for a decision. If the decision is positive, approval is granted. • There is no legal entitlement to the granting of these funds • For measures in Natura 2000 areas, funds from the forest conservation levy can be allocated directly to the foundation capital of the Hessian Natura 2000 Foundation • Funds from the forest conservation levy may not be used for measures that are already supported by public funds or for which there is a legal obligation to implement them Decisions on the use of funds from the forest conservation levy are made in accordance with the state budget.
