Teaser	Would you like to use your deregistered vehicle on the road again? Then you can re-register it with the registration authority.
Volltext	<p>If you want to use your deregistered vehicle on the road again, you must first re-register it.</p> <p>This is a re-registration to the same owner if you are the person who was previously registered as the owner of the vehicle. If there has been a change of keeper, this is referred to as re-registration to a different keeper.</p> <p>You can submit the application in person to the registration authority responsible for you or appoint a representative to do so.</p>
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Registration certificate part I (vehicle registration document) • Valid electronic insurance confirmation (eVB) • Valid general inspection and, if applicable, safety inspection • valid identification document, e.g. identity card or passport of the vehicle owner If the passport is presented, a current registration certificate as well • Account details or SEPA mandate for collecting the vehicle tax of the owner

- if available: completed application forms

If necessary, the following must also be submitted:

If you wish to use a new license plate:

- Registration certificate part II (vehicle registration document)
- if already available: new (desired) license plate reserved in advance including PIN

If you are represented by a third party or a third party:

- Written power of attorney and original identification document of the holder; the authorized person himself must be able to identify himself with his valid identity card or passport.

In the case of re-registration for minors:

- the written declaration of consent of the legal guardians and their original identity cards; if applicable, a certificate of sole custody ("negative certificate") in the case of single parents

Depending on the individual case, the licensing authority may request further or other proof from you.

Voraussetzungen

- The vehicle is currently not in use.
- There has been no change of owner.
- You must not have any outstanding fees and expenses from previous registration processes of more than EUR 30.
- You must not have any vehicle tax debts of EUR 5 or more. This also includes late payment penalties, interest and late payment penalties.
- In Hesse, you must not have any outstanding fees and expenses from previous registration procedures of more than EUR 10 (including late payment surcharges).

	<ul style="list-style-type: none"> • Responsible: local vehicle registration authority • In Hesse, the account details or a SEPA mandate are required to collect the vehicle tax from the owner. • There must be no overdue fees and expenses of more than EUR 10 (including late payment surcharges) • Re-registration via online is only possible if the last deregistration was no longer than 01.01.1995, otherwise no registration certificate part I with released security code is available.
