Teaser	Would you like to use your deregistered vehicle on the road again? Then you can re-register it with the registration authority.
Volltext	If you want to use your deregistered vehicle on the road again, you must first re-register it.  This is a re-registration to the same owner if you are the person who was previously registered as the owner of the vehicle. If there has been a change of keeper, this is referred to as re-registration to a different keeper.  You can submit the application in person to the registration authority responsible for you or appoint a representative to do so.

	<ul> <li>In Hesse, the account details or a SEPA mandate are required to collect the vehicle tax from the owner.</li> <li>There must be no overdue fees and expenses of more than EUR 10 (including late payment surcharges)</li> <li>Re-registration via online is only possible if the last deregistration was no longer than 01.01.1995, otherwise no registration certificate part I with released security code is available.</li> </ul>
