The master craftsman examination consists of 4 parts. The following knowledge is tested in the examination parts:

- practical
- theoretical technical,
- business management
- pedagogical knowledge

Once you have passed the examination, you may use the title of Master Craftsman and receive a certificate. Once you have obtained the master craftsman title, you may also use the title Bachelor Professional.

If you fail a part of the examination, you may repeat it up to 3 times.

## Erforderliche Unterlagen

- Proof that justifies the competence of the Master Craftsman Examination Board
- Proof that you have passed the journeyman's examination or final examination
- Depending on the competent authority, you may need to submit further documents

## Voraussetzungen

You will be admitted to the master craftsman examination if you meet one of the following requirements:

- You must have passed the journeyman's examination or a final examination in a recognized training occupation
- You have a certificate of equivalence in accordance with the Crafts Code The requirements for the 3rd part of the examination do not apply.

## Kosten

Gebühr: 0€ - 100€

The master craftsman examination incurs fees and possibly other costs. Depending on the chamber, these may be borne by the relevant chamber. Depending on the competent chamber, costs may also be incurred for admission to the master craftsman examination procedure. You can find out about the costs from your relevant chamber.

If you would like to take the master craftsman's

examination in a craft or similar trade that does not require a license, you should obtain information in advance from the competent authority and prepare for the examination accordingly. The competent authority is usually the relevant Chamber of Crafts.

- In order to be admitted, you must meet the relevant requirements.
- To be admitted to the examination, you must submit an application to the competent body. Submit the necessary documents together with your application.
- The master craftsman examination consists of 4 parts: Part 1: the examination of the masterly execution of the work customary in the respective craft Part 2: the examination of the required theoretical knowledge in the respective trade Part 3: the examination of the necessary business, commercial and legal knowledge Part 4: the examination of the required vocational and work education knowledge
- The examination is conducted and assessed by the master craftsman examination board. The master craftsman examination board is the state examination authority at the headquarters of the relevant Chamber of Crafts.
- Once you have passed the master craftsman examination, you are entitled to use the title of master craftsman and receive a certificate.
- If you fail a part of the examination, you can repeat this part of the examination up to 3 times.

whether the person being examined has a special qualification in a craft that does not require a license or in a trade similar to a craft can train apprentices properly

- Persons can be admitted who have passed a journeyman's examination or final examination or have a certificate of equivalence
- The master craftsman examination is conducted by a state examination authority established at the headquarters of the competent Chamber of Crafts and Trades
- The master craftsman examination consists of four parts: the examination of the masterly execution of the work customary in the respective craft the examination of the required theoretical knowledge in the respective craft the examination of the necessary business management, commercial and legal knowledge the examination of the required vocational and work pedagogical knowledge
- After passing the master craftsman examination, the title of master craftsman may be used
- The title Bachelor Professional may also be used once the master craftsman title has been obtained
- Failed examination parts may be repeated up to three times
- Responsible: the competent body is usually the respective chamber, usually the Chamber of Crafts and Trades

Contact the chamber responsible for your vocational training. This can be

- the Chamber of Skilled Crafts for vocational training in professions under the Crafts Code,
- the Chamber of Industry and Commerce for vocational training in non-trade occupations,
- the Chamber of Agriculture for vocational training in agricultural and rural domestic science professions
- the Chamber of Lawyers, Patent Attorneys and Notaries as well as the Notary's Office for the vocational training of specialists in the field of law,

- the Chamber of Auditors and the Chamber of Tax Consultants for the vocational training of professionals in the field of auditing and tax consultancy,
- the Chambers of Physicians, Dentists, Veterinarians and Pharmacists for the vocational training of healthcare professionals.
