Teaser	You have successfully completed your studies in Germany and have already received a residence permit to look for a job.
Volltext	As a graduate of a German university, you are legally entitled to a residence permit to look for a job. The residence permit will be issued for a maximum of 18 months directly following your studies. If this maximum period was not used up when the permit was first issued, the residence permit can be extended accordingly. However, if you do not find a job during these 18 months, an extension is not possible and you are obliged to leave the federal territory. This residence permit allows you to work without restriction.

Erforderliche Unterlagen	- Valid national passport- Proof of secure means of subsistence (e.g. employment contract and payslips, bank statements, declaration of commitment by a third party)- Proof of health insurance- Degree certificate, diploma or certificate from your university confirming successful completion of your studies- 1 current biometric photo- Please ask your local immigration office whether you need to submit any further documents.
Voraussetzungen	You are in possession of a residence permit for the purpose of seeking employment after successfully completing your studies in Germany. The maximum period of 18 months has not yet been exhausted. You also meet the general requirements for obtaining a residence permit. These are in particular:- a secure livelihood- a clarified identity- possession of a valid national passport.
Kosten	Cost framework: Fee: EUR 93 - 96
Verfahrensablauf	You can only apply for an extension of a residence permit in person at the foreigners authority responsible for your place of residence You submit the required documents in the original and pay the application fee The foreigners authority checks whether the requirements for issuing the permit have been metIf all requirements are met, the foreigners authority will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH As soon as the eAT is ready, it will be issued to you by the foreigners authority.
Bearbeitungsdauer	Approximately 5 to 6 weeks, depending on the workload at the local immigration office.
Frist	Application before the current residence permit expires. An appointment 4 to 6 weeks before the current residence permit expires is recommended.
