Teaser	If you have found an installation site as an operator of gaming machines, you will need a confirmation for the installation site for the installation of gaming machines with the possibility of winning. You can find out more here.
Volltext	<p>As a trader, you may only set up gaming devices with the possibility of winning prizes (goods prizes, cash prizes) if the competent authority has confirmed in writing that the installation site is suitable for this purpose.</p> <p>The permit that you require for the installation and operation of such gaming devices may be subject to conditions. The conditions may relate to the installation site if this is necessary for the protection of the general public, guests or residents of the respective premises or neighboring properties or in the interest of the protection of minors.</p> <p>The exact provisions regarding installation locations are set out in the Gaming Ordinance (SpielV).</p> <p>A gaming machine where the prize is money (slot machine) may only be installed</p> <ul style="list-style-type: none"> <li>• in accommodation establishments or in rooms of pubs or restaurants where drinks or food are</li> </ul>

Voraussetzungen	<p>In accordance with Section 1 of the Gaming Ordinance, the installation location of a gaming device with the possibility of winning must be in a</p> <ul style="list-style-type: none"> <li>• a pub or restaurant where food and drink can be consumed on the premises, or</li> <li>• in an accommodation establishment, an amusement arcade or similar establishment and</li> <li>• a betting office of a licensed bookmaker</li> </ul> <p>so that the competent authority can confirm that the installation site is suitable.</p>

a suitability certificate for the installation site. The application can be made electronically or in writing.

When setting up in restaurants, the operator of the restaurant must have a restaurant license.

Once you have submitted the application and all documents are complete, the competent authority will check whether you meet all requirements.

If all requirements are met, the competent authority will confirm the suitability of the location for the installation of gaming machines.

Confirmation of the installation location

- In order to be allowed to set up gaming devices with the possibility of winning, the suitability of the installation location must be determined; according to Section 33c of the German Trade and Industry Regulation Act, it must be proven for each installation location of gaming devices with the possibility of winning that it is suitable for this purpose; such a confirmation of suitability by the local competent authority is a prerequisite for the installation of gaming devices with the possibility of winning; In principle, gaming devices with the possibility of winning may only be set up in rooms of bars or restaurants where drinks and food can be consumed on the spot, accommodation establishments, amusement arcades and similar establishments as well as betting offices of licensed bookmakers.
