Siblings <p>If the deceased did not live in the same household as any of these persons, the death grant will be paid in the same order of priority to the person whose maintenance the deceased was responsible for.</p> <p>If there are no beneficiaries, the death grant may be paid to the person who bore the costs of the last illness</p>
