Teaser	If you wish to extend your firearms license for firearms requiring a permit to accompany or carry out guarding activities, you must apply to the competent authority. You can find out more here.
Volltext	<p>You require a firearms license for the security industry as well as a firearms possession card for carrying firearms requiring a permit to accompany or carry out security activities such as the protection of persons or property as well as the transportation of money and valuables.</p> <p>An existing firearms license can be extended before it expires. This is possible twice for up to three years.</p> <p>Employees who work on the basis of official instructions only require a firearms license for the security industry, not a firearms possession card.</p> <p>If you are employed in the security industry, the firearms license issued will be handed over to the person responsible at your employer.</p>

## Sachverhalt

- Proof of expertise

Official certificate of competence or proof from an officially authorized commercial training provider. The certificate of competence must meet the current requirements of § 1 AWaffV. This is regularly the case for certificates of competence issued after 01.04.2003.

- Proof of need

Guarding orders or offers which explicitly state the type and scope of the guarding activity as well as the persons, objects or assets to be protected.

- Proof of liability insurance in the amount of 1,000,000 euros, lump sum for personal injury and property damage

- Proof of safe storage of firearms and ammunition in accordance with § 36 WaffG

- Details of the weapons to be entered in the firearms license (if already known)

for applicants who are employed in the security industry Certificate from the employer:

- of a current employment relationship and use in an activity requiring the carrying of a weapon. The certificate must contain information on the scope (full-time or part-time) and whether the employment relationship is temporary or permanent. Information that is not relevant can be blacked out. stating the type of guarding activity to be carried out (cash transportation, transport of valuables, property protection, personal protection) stating which weapon(s) is/are to be carried (if already known)
- Official or specialist medical or psychological certificate on personal suitability for applicants who have not yet reached the age of 25

## Voraussetzungen

In order for your firearms license for the security industry to be renewed, you must

- at least 18 years old,
- reliable within the meaning of § 5 WaffG and

	<ul style="list-style-type: none"> <li>• be personally suitable within the meaning of § 6 WaffG and</li> <li>• have the required expertise in accordance with § 7 WaffG and</li> <li>• prove that you have a need for firearms in accordance with § 8 WaffG.</li> </ul> <p>In addition, the period of validity of your firearms license must not have expired.</p>
Kosten	Gebühr: 150€ - 200€
Verfahrensablauf	<ul style="list-style-type: none"> <li>• The application for renewal of the permit must be submitted to the competent authority in writing or electronically.</li> <li>• The competent authority will check the documents.</li> <li>• If the examination is positive, the authority will issue the extension of the firearms license for the security business.</li> <li>• The extension of the permit must be granted if the period of validity of the existing firearms license has not yet expired.</li> </ul>

Frist	The application for renewal must be submitted before the existing firearms license expires.

permit to accompany or carry out guarding activities, such as personal or property protection and the transportation of money and valuables

- The permit to carry a firearm can be extended twice for up to three years
- Extension of an existing firearms license before the expiry date
- Prerequisites: Completion of the 18th year of age  
Required reliability and personal suitability  
Required expertise  
Need to carry a weapon (guarding particularly endangered persons or objects)  
Liability insurance  
Official or specialist medical or psychological certificate of personal suitability for applicants who have not yet reached the age of 25
- Responsible body: District police authority
