administrative charges

Parking incorrectly also generally constitutes an administrative offense. Depending on the type, you will be informed of this in a warning or report and a warning or fine will be imposed. The amount of the warning or fine depends on the parking offense.

Costs are also incurred if the towing company has been commissioned but you have moved your vehicle before the tow truck arrives. In this case, the towing order will no longer be carried out, but the empty run of the tow truck must be paid for.

Once the towing costs and any additional fees have been paid, the vehicle can usually be returned. Information on this can be obtained from the responsible regulatory authority or the police.

**Erforderliche Unterlagen**

You will usually need the following documents to collect the vehicle:

- Vehicle registration document or vehicle registration certificate part I or part II
- Identity card or passport with photo
- Written power of attorney (for third-party collection)
- Cash if necessary

about the whereabouts of the vehicle to find out whether your car has been towed away or stolen

- Towing costs: calculated according to the type of vehicle, the time of towing and the length of time the vehicle is with the towing company
- Administration fees: calculated according to the cost of deploying the personnel and equipment of the enforcement and traffic service
- Incorrect parking is an administrative offense, therefore additional warning or fine
- The vehicle can usually be returned after payment of the towing costs and any additional fees
- Information can be obtained from the responsible regulatory authority or the police
