- Access roads from agricultural and forestry properties

You are acting in breach of the regulations if you exercise a special use without the corresponding permit or do not comply with the conditions imposed. (§ 59 StrWG NRW / § 23 FStrG). Such administrative offenses can be punished with a fine.

You do not require a special use permit in the following cases:

- You require a special use permit under road traffic law. For example, for events. For this, you need an event permit from the road traffic authority, which automatically includes the special use permit.

The intended special use is in connection with a building project for which you require a building permit. In this case, the building permit automatically includes the special use permit.

## Erforderliche Unterlagen

The competent authority may request further documents, e.g.

- Site plan (true to scale),
- photos,
- sketches.

## Kosten

Fees for special uses on state and federal roads outside of local thoroughfares are assessed on a case-by-case basis. They take into account, among other things, the type and extent of the impact on the road and the economic interest of the applicant.

## Verfahrensablauf

You must apply for a special use permit from the responsible authority. The granting of the requested special use is at the discretion of the authority.

Above all, it examines what effects a permit would have on the use of the road.

It must weigh up the public interest in the safe use of
