In addition, you may lose your right to vote due to a civil or criminal court decision in your country of origin.
Erforderliche Unterlagen	Judicial decision in Germany or civil or criminal decision in the country of origin.
Voraussetzungen	You have been deprived of your right to vote by a court decision in Germany or by a civil or criminal law decision in your country of origin.

Verfahrensablauf	Exclusion from the European elections is carried out as follows: • the courts send the relevant judgments to the municipal administration, • the municipal administration notes the exclusion from the right to vote in the register of residents.
