Volltext	As a German or a national of the European Union who has reached the age of 16 on election day, you are entitled to vote in the electoral area in which you have had your residence, main residence or habitual abode without a residence outside the electoral area since at least the 16th day before the election.
	You will be entered in the electoral roll ex officio as a person entitled to vote if you are entitled to vote on the 42nd day before the election and are not excluded from the right to vote. If you have moved in and are registered after the 42nd day but up to the 16th day before the election, you will be entered in the voters' register ex officio.
	If this does not happen, you can apply to be entered by the start of the inspection period. You will be granted access on working days from the 20th to the 16th day before the election during the general opening hours of the municipal authority.
	You can check the accuracy and completeness of your own data. You can also check the data of other persons if you yourself are entitled to vote and can provide credible evidence that the electoral roll is incorrect or incomplete.
	You can lodge an objection to the electoral roll with the municipal administration in writing or for the record within the inspection period. If you lodge an objection based on the data of another person, this person must be heard before a decision is made by the authority. The mayor must notify the decision to the objector and the person concerned, if applicable, no later than the 10th day before the election. An appeal against the mayor's decision may be lodged within 3 days of notification, on which the supervisory authority shall decide.
Erforderliche Unterlagen	conclusive documents proving the need to correct the electoral roll or, in the absence of an entry, proof of eligibility to vote

Voraussetzungen	The electoral roll for municipal elections can be corrected under the following conditions: • If the electoral roll proves to be incorrect, the electoral roll will be corrected. • If proof of eligibility to vote can be provided despite a missing entry, the voters' register will be supplemented accordingly.
Kosten	none
Verfahrensablauf	 The procedure for correcting the electoral roll for local elections is as follows: After inspecting the electoral roll, you discover an error in the electoral roll or you are not entered although you are entitled to vote. You lodge an objection and provide suitable evidence to substantiate the facts. The authority corrects the electoral roll or sends a rejection notice. If you are subsequently registered, you will receive a voter's notification. An appeal can be lodged against a negative decision.

	excluded from the right to vote is established on the 42nd day before the election are entered in the voters' register • Persons who have moved to the area after the 42nd day but up to the 16th day before the election and are registered with the registration office are also entered in the electoral roll ex officio • Registration possible on request until the start of the inspection period • Inspection is granted on working days from the 20th to the 16th day before the election during the general opening hours of the municipal authority • The accuracy and completeness of your own data can be checked • The accuracy and completeness of the data of other persons (except for persons with an information block) can be checked by eligible voters if they can credibly demonstrate facts that may result in the inaccuracy or incompleteness of the electoral roll • from the beginning of the inspection period, persons can be added or deleted if an objection is made in good time • The mayor must correct obvious inaccuracies by the day before the election • responsible: Municipality
