- Completed application form
- Certificate of instruction in player and youth protection (Pursuant to § 33c of the Trade, Commerce and Industry Regulation Act, a certificate issued by the Chamber of Industry and Commerce must prove that the applicant has been instructed in the knowledge required to practice the trade).
- Social concept (Pursuant to Section 33c (2) of the Trade, Commerce and Industry Regulation Act, a social concept must be submitted in order to obtain a permit to install gaming machines with the possibility of winning. The social concept describes the measures to be taken to prevent the socially harmful effects of gambling).
- Excerpt from the Commercial Register or, in the case of legal entities still in the process of being established, the certificate of incorporation and shareholders' agreement.

## Voraussetzungen

- A permit according to § 33c Gewerbeordnung requires your reliability under trade law. The reliability is checked by the authority during the application process.

- First, you must obtain all the necessary documents and submit them to the authority with the written application.
- The authority checks your reliability under trade law.
- If all requirements are met, you will receive the permit with a fee notice.
