Teaser	The disposal of waste and thus also of household waste/residual waste from private households and other waste for disposal from other sources is the responsibility of the districts and independent cities.
Volltext	The disposal of waste from private households and other disposal waste from other sources is the responsibility of the public waste management authorities (districts and independent cities). Regulations on the applicable waste disposal system and individual provisions are laid down in the statutes. These include information on waste fees, waste containers (prescribed size of waste garbage can, ordering options), waste calendar (collection intervals, tour schedules for hazardous waste vehicles), collection and delivery systems for various types of waste (e.g. green waste, e-waste, paper), disposal of organic waste, disposal of bulky waste and the types of waste permitted for disposal in the gray garbage can.

Kosten	Inquiry with the public waste disposal authorities required As is the case for waste disposal in general, there is no standardized nationwide fee regulation for the disposal of household waste/residual waste by the districts and independent cities. Information on the costs incurred can be found in the respective waste fee statutes of your public waste disposal authority.
