Volltext	As the operator of an evaporative cooling system, a cooling tower or a wet separator, you are obliged to inform the competent authority immediately in accordance with Appendix 3 Part 1 of the 42nd BImSchV and within a period of 4 weeks in accordance with Appendix 3 Part 2 of the 42nd BImSchV if a laboratory test reveals an exceedance of the measure values for the concentration of Legionella in industrial water specified in Appendix 1 of the 42nd BImSchV. The competent authority shall receive the information and examine the measures you have taken. If necessary, the authority will also contact you.
