Teaser	You can have your residence permit extended for the purpose of school-based vocational training before the end of its period of validity if you want to continue your school-based vocational training in Germany.
Volltext	<p>The residence permit for the purpose of school-based vocational training is a temporary residence permit. You can apply for the extension of the residence permit if your vocational training is to be continued beyond the period of validity of your residence permit.</p> <p>Apply for the extension of your residence permit at least eight weeks before the expiry of the time limit at the immigration authority responsible for your place of residence.</p> <p>The same conditions apply to the extension of the residence permit for the purpose of school-based vocational training as for the purpose of granting it.</p> <p>In the event of an extension, your residence permit will again be limited in time. The residence permit for the purpose of school-based vocational training is extended for the duration of the training.</p> <p>As a rule, the residence permit cannot be extended if</p>

Voraussetzungen	<ul style="list-style-type: none"> <li>• You have a recognised and valid passport or passport substitute as well as a valid residence permit for the purpose of school-based vocational training in accordance with § 16a paragraph 2 of the Residence Act.</li> <li>• The validity period of your residence permit will expire in the near future.</li> <li>• There is no interest in expulsion against you.</li> <li>• Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany.</li> <li>• Your livelihood is secured for the duration of your vocational training.</li> <li>• You have a training place in Germany that leads to a state-recognised vocational qualification in accordance with federal or state regulations.</li> </ul>
Kosten	<ul style="list-style-type: none"> <li>• Extension of the residence permit for the purpose of school-based vocational training: for a further stay of up to three months: EUR 96 for a further stay of more than three months: EUR 93</li> <li>• Under certain conditions, a fee reduction or exemption may be considered</li> </ul>
Verfahrensablauf	<p>The extension of your residence permit must be applied for at the immigration authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• Depending on the foreigners' registration office and concerns, it may be possible to apply via the Internet. - During the appointment, your application will be accepted and your proofs will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT).
- In the event of an electronic application, the Foreigners' Registration Office will contact you after receipt of your online application in order to arrange an appointment at the Foreigners' Registration Office. During the appointment, your proofs will be checked (please bring them to the appointment) and your fingerprints will be taken for the issuance of the eAT card.
- If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced.
- After about six to eight weeks, you can pick up an eAT card at the Foreigners' Registration Office.

Fees apply for the extension of the residence permit. The timing and form of payment vary depending on the authority

## Frist

- Extension of the residence permit: at the latest eight weeks before the expiry of your still valid residence permit for the purpose of school-based vocational training
- Objection period: 1 month

- Residence permit for the purpose of school-based vocational training may be extended if its period of validity expires in the near future and school-based vocational training is to be continued.
- The extension must be applied for no later than eight weeks before the expiry of the time limit.
- An extension of the residence permit for the purpose of school-based vocational training is only possible if the conditions that were met when it was first issued continue to be met.
- Upon extension, the residence permit will again be limited in time.
- An extension is excluded if this has already been excluded by the Foreigners' Registration Office at the time of granting or the last extension.
- Depending on the immigration office and concerns, the application is possible via the Internet or only in person.
- Renewal fees apply. The timing and form of payment vary depending on the authority
- Responsible: the immigration authority responsible for the applicant's place of residence
