Volltext	As the operator of a new plant, you are obliged to notify the competent authority of it no later than one month after the initial filling with service water. Existing plants had to be reported by 20 August 2018. In addition, changes to the plant and a plant shutdown must be reported immediately, at the latest within one month. In the event of a change of operator, the new operator must notify the competent authority of this change immediately, but at the latest within one month.
