| Volltext                      | <p>If you as a traditional shooter need weapons and ammunition to maintain customs, a need for their acquisition and possession is recognized. The permit is limited to single-loader long guns and up to three repeating long guns as well as the ammunition intended for this purpose. As proof you need a certificate from the Customs Protection Association that you need these weapons to maintain the customs. An indication of customs is a long-standing tradition and practice. The use of weapons may only be a necessary part of the maintenance of customs and not the predominant purpose.</p> |
