Teaser	lf you wish to participate in a European Voluntary Service under EU Directive 2016/801, you can apply for a temporary residence permit
Volltext	As a participant in the European Voluntary Service, you will be granted a residence permit for the duration of your voluntary service, but for a maximum of one year. The agreement between you and the host institution must contain the essential information (job description, duration, working hours, working conditions, supervision, remuneration and, where applicable, training). If you have not yet reached the age of 18, you also need the consent of your legal guardian. In addition to participation in voluntary service, additional employment is not permitted.

	<ul> <li>Visa, if required for entry</li> <li>Current biometric photo in passport format (45 x 35 mm)</li> <li>Agreement with the host organisation for the implementation of the European Voluntary Service, including a description of the job, details of the duration of the voluntary service, working hours, working conditions, supervision, remuneration and any training included.</li> <li>Proof of health insurance coverage</li> <li>Before the age of 18: consent of the legal guardians</li> <li>In individual cases, the Foreigners' Registration Office may require less or further proof.</li> </ul>
Voraussetzungen	<ul> <li>You have a recognized and valid identity document (e.g. passport or passport substitute) and, if this was required for entry into Germany - an appropriate visa.</li> <li>You have concluded a formal agreement with a reputable institution on the implementation of the voluntary service.</li> <li>There is no statutory ground for refusal (for example, you should not be one of those beneficiaries of international protection in Germany, who have applied for international protection, whose deportation is temporarily suspended or who has been granted temporary protection; nor should the host institution have been established for the sole purpose of facilitating the entry and residence of foreigners).</li> <li>You have sufficient health insurance coverage.</li> <li>There is no interest in expulsion against you.</li> <li>Your stay does not endanger or impair the interests of the Federal Republic of Germany.</li> </ul>
Kosten	Fee: 100 EUR
Verfahrensablauf	<ul> <li>Find out whether your immigration authority allows you to submit your application online or has a special application form.</li> <li>If the application is only possible in person, make an appointment at the Foreigners' Registration Office. In the case of an online application, the Foreigners' Registration Office will contact you after receipt of your application to make an appointment.</li> <li>During the appointment, your identity and documents will be checked (please bring your</li> </ul>

	<ul> <li>documents, preferably original, to the appointment).</li> <li>If your request is granted, your fingerprints will be taken for the production of an electronic residence title (eATKarte). The Foreigners' Registration Office commissions Bundesdruckerei to produce the eAT card. After completion, you will receive information and can pick up the residence permit at the responsible office. The eAT card must always be picked up in person.</li> <li>If your application is rejected, you will receive a rejection notice.</li> </ul>
Bearbeitungsdauer	Duration approx. 8 weeks Note for further information on processing time: The production of the electronic residence title by Bundesdruckerei takes about 4 to 6 weeks.
Frist	Duration: 6 to 8 Remark (for more information on the deadline): At the latest 8 weeks before the expiry of your valid visa or before the start of your voluntary service, the application should be received by the Foreigners' Registration Office. : maximum 1 year Remark (for more information on the deadline): The residence permit is issued for a maximum of 1 year. Kurztext	<ul> <li>Residence permit for the purpose of gainful employment Grant for participation in the European Voluntary Service</li> <li>Third-country nationals can obtain a temporary residence permit to participate in a charitable project in Germany.</li> <li>Participants in the European Voluntary Service (EVS) are issued with a residence permit for the duration of their voluntary service, up to a maximum of one year.</li> <li>Additional employment is not permitted in addition to</li> </ul>
