| Teaser                           | If you are obliged to cover the funeral costs of a<br>deceased person even though you do not have the<br>financial means to do so yourself, you can apply to the<br>social welfare provider to have the costs covered.   |
| Volltext                         | In the event of a death, the relatives of the deceased<br>person usually have to take care of the funeral and<br>cover the costs for the time being if the estate or other<br>funds, such as from a death benefit insurance policy,<br>are not sufficient or not sufficient in full to cover the<br>funeral costs.                             |
|                                  | Who is obliged to cover the funeral costs is regulated by law. These may be the following persons:   |
|                                  | <ul> <li>contractually obligated persons</li> <li>heirs</li> <li>persons liable to pay maintenance</li> <li>Persons obliged to pay for the funeral under the public funeral law of the federal states</li> </ul>   |
|                                  | If you are obliged to pay the costs of a funeral but are<br>not in a financial position to do so, you can apply to the<br>relevant social welfare office to have the costs covered.<br>The social welfare office will then check to what extent<br>you can reasonably be expected to bear the costs.   |
|                                  | The social welfare office will cover the costs of a<br>simple, appropriate and dignified funeral. This includes<br>the reasonable costs for the coffin, mortuary and grave<br>fees as well as the costs for laying out the grave. This<br>also applies to urn burials. The costs of hospitality for<br>mourners, for example, are not covered. |

|                                 | The social welfare office that provided social assistance<br>for the deceased person until their death is<br>responsible. However, if the deceased person did not<br>receive social assistance, the social welfare office in<br>whose area the place of death is located is responsible.<br>If a person with German nationality who was not<br>receiving social assistance dies abroad, responsibility<br>depends on the individual case.  |

| Voraussetzungen                 | <ul> <li>You are obliged to pay the funeral costs.</li> <li>Neither the estate of the deceased person nor other<br/>funds received as a result of the death, such as<br/>insurance payouts, will cover the funeral costs.</li> <li>They cannot bear the costs from their own resources,<br/>or cannot bear them in full, or cannot reasonably be<br/>expected to bear the funeral costs.</li> <li>The costs of the funeral are reasonable.</li> </ul>  |
| Kosten                          | There are no costs.  |
| Verfahrensablauf                | <ul> <li>If you wish to apply for assistance with funeral costs:</li> <li>Submit an application to the responsible social welfare provider to have the costs covered.</li> <li>If necessary, you must ask the responsible social welfare provider which costs will be covered in each individual case before appointing the funeral director,</li> <li>The social welfare agency will check the documents you have submitted and your income and financial circumstances.</li> <li>You will receive a notice of approval if all requirements are met.</li> </ul> |

| Kurztext          | <ul> <li>Assistance with funeral costs in accordance with §74<br/>SGB XII</li> <li>In the event of a death, certain persons are obliged to<br/>bear the funeral costs. These include, for example<br/>contractually obligated persons heirs persons liable to<br/>pay maintenance Persons obliged to bury according to<br/>the public burial law of the federal states</li> <li>A person obliged to pay for the funeral can apply for<br/>the funeral costs to be covered if neither the estate nor<br/>other payments, e.g. death benefit insurance, are<br/>sufficient for the funeral, the person cannot bear the<br/>costs themselves or cannot reasonably be expected to<br/>do so and the costs of the funeral are reasonable.</li> <li>The income and assets of the person obliged to pay<br/>for the funeral will be taken into account when<br/>deciding on the application</li> <li>Responsible: the social welfare institution responsible<br/>for the deceased person</li> </ul> |
