Teaser	If you want to drive a truck, you must have your driving license extended to category C, CE, C1 or C1E at the driving license authority. These extended driving license categories are limited to 5 years.
Volltext	To drive trucks or vehicle combinations consisting of a truck and a trailer, you need an extended driving license for category C, CE, C1 or C1E. You can apply for the extension of your driving license at the driving license authority in your place of residence. If your driving license is extended to include categories C, CE, C1 or C1E, it will be issued for a limited period of 5 years. You must apply for an extension before this period expires.
	Depending on the category, the extended driving license entitles you to drive various trucks or vehicle combinations consisting of a truck and a trailer. To apply for an extension, you must meet various requirements.

	 Motor vehicles with a gross weight of more than 3.5 tons and a maximum of 8 seats in addition to the driver's seat Trailers with a total weight of up to 750 kg Required driving license: Class B

• Minimum age: 21 years or 18 years if you drive a truck professionally

Class CE driving license:

- Motor vehicles with a gross vehicle weight of more than 3.5 tons and a maximum of 8 seats in addition to the driver's seat
- Trailers with a total weight of more than 750 kg
- Required driving license: Class C
- Minimum age: 21 years or 18 years if you drive a truck professionally

Class C1 driving license:

- Light commercial vehicles with a gross weight of between 3.5t and 7.5t and a maximum of 8 seats in addition to the driver's seat
- Trailers with a total weight of up to 750 kg
- Required driving license: Class B
- Minimum age: 18 years

Class C1E driving license:

- Light commercial vehicles with a gross weight between 3.5t and 7.5t and a maximum of 8 seats apart from the driver's seat
- Trailers with a total weight of more than 750 kg, maximum weight equal to the unladen weight of the towing vehicle
- Maximum total weight of the combination of 12 tons
- Required driving license: Class C1
- Minimum age: 18 years

Erforderliche Unterlagen

- Identity card or passport with current registration certificateCurrent biometric photo (size 45x35 mm, portrait format, frontal view)
- Eye test certificate (not older than 2 years)
- Proof of physical and mental aptitude (not older than 1 year)
- Current driving license
- Details of driving school

Voraussetzungen

- Your main place of residence is in Germany.
- You have a driver's license with the required category.

	 You have reached the minimum age for the respective category when the driver's license is issued. You can submit your application at the earliest 6 months before reaching the minimum age. You are qualified to drive a truck. You have successfully completed the required theoretical and practical training and examination for driving a truck in the category applied for.

Verfahrensablauf	The fee is based on the scale of fees for road traffic measures (GebOSt).
