Kosten	Abgabe: 20€ - 300€ Costs are incurred. The amount of the costs depends on the type of event and the costs for fixing. As a rule, the costs are between 20.00 euros and 300.00 euros
Verfahrensablauf	• You submit an application for a change in the determination of an event with all the necessary documents by post or e-mail to the competent body. • The competent authority will check your documents. If necessary, it will request further documents or information from you.
