Teaser	If you wish to operate a business in the livestock trade/livestock transport/collecting point sector, you must notify the competent authority before commencing the activity.
Volltext	Anyone wishing to trade livestock commercially or transport livestock as part of the division of labor in livestock production or operate an assembly center must notify the competent authority before starting the activity. If an assembly center is to be operated, the location of the assembly center must also be specified. Changes must be reported immediately.
Erforderliche Unterlagen	• Personal documents • Company documents Please enquire with the competent veterinary authority.
Voraussetzungen	The commercial trade/transport of livestock or the operation of an assembly center may only begin once the notification has been submitted.
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the

Verfahrensablauf	• Applications are usually made in writing to the competent veterinary office. In some cases there are standardized application forms. • The health certificate is issued after a successful examination by the authorities
Bearbeitungsdauer	1 - 3 Woche(n) Once you have submitted all documents in full, the responsible office will process them promptly. The processing time depends on the type and scope of the required health certificate. The application must be submitted several weeks in advance
Frist	Before the start of the commercial activity. Please submit the application several weeks before starting the activity.
