Teaser	As a church or religious community, you can apply for a general open license for the export of cultural property to third countries under certain conditions.
Volltext	<p>Do you, as a church or religious community that is recognized as a public corporation, regularly export cultural property in your holdings temporarily from Germany to one or more third countries? Then you can apply for a general open license for the export of cultural property to third countries. Third countries are countries that do not belong to the European Union (EU).</p> <p>The general open license is particularly recommended if you frequently</p> <ul style="list-style-type: none"> <li>• take part in public exhibitions,</li> <li>• have cultural property restored or</li> <li>• give researchers the opportunity to examine cultural</li> </ul>

The general open license can be granted for a maximum of 5 years.

You can apply for the general open license from the competent authority of the federal state in which the headquarters of your institution is located.

## Erforderliche Unterlagen

- Consent of your church or religious community

## Voraussetzungen

- You are a church that preserves cultural property or a religious community recognized as a public corporation.
- You guarantee that the cultural property will be re-imported undamaged and in good time.
- Your church or religious community has given its consent to the application for the export license.

## Kosten

## Verfahrensablauf

You can only apply for a permit for the temporary export of cultural property in writing.

- Download the corresponding PDF form Export license for export to countries outside the EU and fill it out.
- Print out the PDF form once on one side.
- The PDF contains 2 copies of the export license application.
- Both copies must be completed accordingly.
- Attach the necessary supporting documents to both copies.
- If necessary, sign and stamp the copies in the specified places.
- Send both copies and the relevant supporting documents by post to the competent authority.
- The competent authority will check your application and decide whether to issue the export license.
- If the decision is positive, the second copy will be provided with the license and sent back to you.
- Please carry this license with you when exporting the cultural object.
- If the decision on your application is negative, you will receive a written decision with a statement of reasons and information on legal remedies.
