	Over-the-counter medicinal products include:
	<ul> <li>Medicinal plants and parts of them, for example violet root</li> <li>Mixtures of whole or cut plants or parts of plants, e.g. cough and bronchial tea</li> <li>Pressed juices from fresh plants</li> <li>Distillates from plants</li> <li>Healing earth, bathing-peat, bath preparations, soaps</li> <li>Medicinal waters and their salts</li> <li>Plasters</li> <li>Disinfectants for external use</li> </ul>
Erforderliche Unterlagen	<ul><li>Proof of expertise</li><li>official photo ID for identification at the start of the examination</li></ul>
Voraussetzungen	Expertise test
	<ul> <li>Qualified persons must demonstrate knowledge and skills in the proper filling, packaging, labelling and storage of medicinal products and know how to place medicinal products on the market.</li> <li>Those who cannot provide such proof must take an examination of expertise before an examination board of a Chamber of Industry and Commerce (IHK).</li> <li>Examination applicants register with the Chamber of Industry and Commerce in whose chamber district the place of employment/training or further education is located or the applicant has or last had his or her habitual residence.</li> </ul>
	Note: With a university degree or vocational training in pharmacy, you may already have this expertise and do not need to prove it again.

Verfahrensablauf	<ul> <li>Inform the Landesdirektion Sachsen in an informal letter that you would like to sell over-the-counter medicinal products.</li> <li>Enclose the necessary evidence (if available) proving your expertise or the expertise of your employees with your letter.</li> </ul>
	The IHK will confirm the date of the examination. The examination comprises 50 multiple-choice questions and five open questions, for example on
	<ul> <li>the proper storage of over-the-counter medicines,</li> <li>possible dangers in the event of overdosage of the active ingredients, and</li> <li>legal regulations for handling and selling.</li> </ul>
	After successful completion of the examination, you will receive your certificate.
Bearbeitungsdauer	You will usually receive the certificate a few days after passing the exam.
