<b>Erforderliche Unterlagen</b>	<p>The following documents must be enclosed with the application for a certificate:</p> <ul style="list-style-type: none"> <li>• officially certified copies or transcripts of the complete school leaving certificate which is to be subjected to the equivalence assessment</li> <li>• certified copy of the school leaving certificate of the general education school</li> <li>• in the case of a change of name, proof of this (e.g. marriage certificate)</li> <li>• a complete curriculum vitae in table form, signed by the applicant's own hand, with details of school education and vocational training</li> <li>• if applicable, proof of professional activity until admission to the educational institution whose degree is to be subjected to the equivalence assessment</li> </ul>
