There is no obligation to take advantage of the opportunity to be heard. If you do not take advantage of this opportunity, the fine will be issued on the basis of the facts described.  Examples of administrative offences subject to fines:  • seriously exceeding the speed limit • dangerous overtaking manoeuvres • Driving at red lights • insufficient safety distance • Driving a motor vehicle under the influence of alcohol over 0.5 per mille  In addition to the fine, the driving licence authority can award points in the central traffic register or revoke the driving licence for one to three months. |
