## Voraussetzungen

Eligible applicants

- Educational institutions and companies that provide trainees in IHK professions with additional qualifications

Funding requirements

Funding is possible if

- the training relationships are in-company vocational training relationships
- the vocational training is provided in recognised training occupations pursuant to the Vocational Training Act (Berufsbildungsgesetz)
- the training contract is entered in the register of vocational training contracts of the Chamber of Industry and Commerce at the time of application

The content of the additional qualification must not be part of the applicable training regulations. However, it must have a factual connection with the training occupation.
