	<ul> <li>You fill out your application online and an electronic assistant guides you through the process.</li> <li>Once you have completed the entry, the SAB will send you a confirmation e-mail containing your application and a summary of all the information you have entered.</li> <li>Please print out the application, sign it and submit it together with the required attachments to the State Office for the Environment, Agriculture and Geology (LfULG) for forwarding to the SAB.</li> <li>After the SAB has examined the application, you will receive a decision as to whether your project will be funded and, if so, how much.</li> <li>Payment:</li> </ul> Before the lump sum is paid out, the attendance of the
