Handlungsgrundlage	<p>Note: There is no legal basis for issuing a permit to place advertising outside built-up areas. Teaser	You can also use public roads and paths for purposes other than traffic and public use. If you want to advertise in public spaces, you must apply for a special use permit.
Volltext	Anyone can use public roads, paths and squares as intended. If you want to advertise something outside enclosed spaces or in public areas, for example by putting up posters, this constitutes a use that goes beyond the normal use of public space (common use). You need a special use permit for this. You must have the special use permit before you start advertising.
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Informal application for a special use permit • Documents describing the type and scope of the special use (e.g. a design of the advertising medium and a site plan) • Coordinates of the locations
Voraussetzungen	<ul style="list-style-type: none"> • They do not restrict the safety of traffic. • They do not disproportionately impair the ease of traffic flow.

	<ul style="list-style-type: none"> • They do not disproportionately impair public use. • They do not disproportionately impair road components. • They do not disproportionately restrict environmental concerns. • They do not disproportionately restrict urban development interests. • They do not disproportionately restrict public interests, including the generation of revenue from the use of the path. • They do not disproportionately restrict the public or private rights of third parties.
Kosten	A fee is charged for the granting of the permit. Fees may also be charged for the use of the area. The amount of the fees depends on the type, scope and location of the special use.
Verfahrensablauf	<p>If you wish to apply for permission for special use, you can submit the application informally in writing to the competent authority.</p> <ul style="list-style-type: none"> • You submit an informal written application to the competent authority. • Describe the type, location, extent and duration of the planned special use as precisely as possible. You should also state the impact on the affected area. • The competent authority will check your application and request any missing documents or information from you. • After the review, you will receive a notice of approval or rejection.
Bearbeitungsdauer	Duration (within a range): 1 week to 3 weeks Note for further information on processing time: The processing time depends on the type and scope of your application and the quality of the documents submitted.
Frist	Deadline type: Application deadline Duration (with fixed time): 3 weeks Note (for further information on the deadline): You must have the permit before you start the special use.

Hinweise	<p>Even if all factual and legal requirements are met, you are not entitled to be granted a special use permit. The competent authority decides on your application at its own discretion.</p> <p>The competent authority will grant you the special use permit for a limited period of time and subject to revocation. This means that the permit issued can be withdrawn. The permit is usually issued with conditions that you must fulfill.</p> <p>The competent authority may require you to pay for the removal of any damage caused by your special use. The competent authority may also require you to make an advance payment or deposit a sum of money as security.</p>

Kurztext	<ul style="list-style-type: none"> • If advertising is carried out outside enclosed spaces or on public roads, this is outdoor advertising. • If a public area is to be used for advertising, this constitutes special use of the public area. • A special use permit must be applied for • The special use permit must be obtained before the special use is started. • The special use must not adversely affect persons or public interests. • Permission is granted for a limited period of time or subject to revocation at any time • Permission may be subject to conditions
