Teaser	As the operator of a water supply or non-drinking water system, you are obliged to register your system with the responsible health authority. This also applies to significant changes to the system or a change of operator.
Volltext	Obligations of the system operators: Every water supply or non-drinking water system must be registered with the local health authority. This obligation applies to the initial installation as well as to significant structural or operational changes and the transfer of ownership. This serves to ensure drinking water quality and health precautions. Registration process: • No documents required: You do not need to submit any documents to register your system. • No fees: The registration itself is free of charge. Possible costs only arise for a necessary on-site inspection by the public health department. • Confirmation and inspection: After registration, you will receive confirmation from the health authority. They will then contact you to discuss the next steps.

After you have entered and confirmed all the details, you will receive confirmation of the registration from the responsible health authority. Your health authority will contact you for an on-site inspection of your water supply system and coordinate the next steps with you.
