| Volltext                      | <p>The European firearms pass allows holders of firearms possession cards to temporarily take weapons and ammunition with them when visiting another EU member state or Schengen state. It only allows short-term, cross-border transportation of your weapons for a purpose that is covered by your legal firearms requirements (e.g. hunting trip, participation in a shooting event).</p> <p>The European firearms pass is valid for 5 years and you can have it extended twice for 5 years at a time.</p> <p>You may take the corresponding ammunition for the registered weapons with you, but only as much as you are likely to need. Experience has shown that you will need less ammunition as a hunter than as a sport shooter.</p> <p>Not every weapon that is registered in the European Firearms Pass may automatically be taken abroad. The respective firearms regulations of the host country and all countries through which you are traveling must be observed. Appropriate permits from countries to be</p> |

You will need other permits for this.</p> |
