| Volltext                 | In order to be admitted to the hunting examination,<br>you must provide evidence of comprehensive training.<br>This includes at least 120 hours of instruction in all<br>relevant subject areas such as weapon handling, game<br>diseases and nature conservation. The training<br>includes both theoretical and practical components,<br>which you can complete at the Saarland Hunters'<br>Association or a recognized hunting school.<br>Your application for admission to the examination<br>must be submitted at least five weeks before the start<br>of the examination, together with a current police<br>clearance certificate. After successfully passing the<br>examination, you will receive a certificate that entitles |

| Verfahrensablauf | If you wish to apply for admission to the hunting<br>examination, you can submit the application in writing<br>or, if available, online. You can obtain the application<br>form from the relevant office or, depending on the<br>service, it can be downloaded from the Internet. It is<br>also possible to use an online service. The procedure<br>does not change:<br>• First, you must register with the Saarland Hunters'<br>Association or a recognized private hunting school for<br>the preparatory course for the hunting test.<br>• Complete the required theoretical and practical<br>training units, which comprise a total of 120 hours.<br>• Collect all the necessary documents, including your<br>police clearance certificate and proof of shooting<br>achievements.<br>• Submit the application for admission to the<br>examination to the Saarland Hunters' Association at<br>least five weeks before the start of the examination.<br>• After examining your documents, the examiner will<br>decide on your admission.<br>• If you are successfully admitted, you will take the<br>examination, which consists of three parts: Weapons<br>handling, written examination and oral-practical<br>examination.<br>• After the examination, you will receive the results and<br>your examination certificate. This certificate confirms |
