Volltext	<p>A new decision on the payment of housing benefit must be made ex officio if, during the current approval period, there is a more than temporary</p> <ul style="list-style-type: none"> <li>• the number of household members to be taken into account is reduced to at least one household member to be taken into account</li> <li>• the rent or charge to be taken into account less the total amount for relief on heating costs is reduced by more than 15 percent</li> <li>• the total income is increased by more than 15 percent</li> </ul> <p>the total income can also increase by more than 15 percent if the number of household members to be taken into account increases.</p> <p>The housing benefit is recalculated from the time of the change in circumstances, i.e. retrospectively if necessary.</p>
Erforderliche Unterlagen	In order to check whether a new decision is to be made ex officio on the payment of housing benefit with effect from the time of the change in circumstances, canceling the grant notice, the housing benefit office

	can request documents from you if these are required for the decision. You are obliged to cooperate with the housing benefit authority.

Verfahrensablauf	<p>The recalculation is carried out ex officio. You are obliged to notify the housing benefit authority immediately of any changes that could lead to a reduction in housing benefit.</p> <p>After checking the changes that have occurred, the housing benefit authority will issue a decision. The recalculation can therefore also lead to a reclaim of housing benefit paid in excess.</p>
Bearbeitungsdauer	
Frist	Housing benefit is recalculated from the time of the change in circumstances. A retroactive recalculation of housing benefit is therefore possible. Recipients of housing benefit are obliged to notify the housing benefit authority immediately of any changes that may lead to a reduction in housing benefit.
weiterführende Informationen	Your specific notification obligations can also be found in your approval notice.
Hinweise	The housing benefit authority regularly checks the household members by comparing data - also in automated form - in particular with the pension insurance data office.
Rechtsbehelf	Objection Specific information on how to lodge an objection in due form and time can be found in the information on legal remedies in the notification.
