Teaser	Only claims for payment of a specific sum of money in euros can be asserted in the dunning procedure.
Volltext	Only claims for the payment of a specific sum of money in euros can be asserted in dunning proceedings. If, for example, you want to enforce the delivery of goods or the eviction of living space in court, the dunning procedure is not permitted. The special feature of the dunning procedure is that the court does not check whether the creditor is actually entitled to the claim asserted. Anyone who receives a payment order must therefore check for themselves whether they owe the creditor the sum of money stated therein. Upon your proper application, the dunning court will issue a default summons, which will be served on the defendant ex officio. If your defendant lodges an objection, the proceedings will be transferred to the trial court responsible for the legal dispute if you or the defendant apply for contentious proceedings to be conducted. The claim will then be decided by way of contentious civil proceedings. If the defendant does not file an objection to the order for payment within the two-week objection period, you can apply to the dunning court for an enforcement order. If the defendant files an objection against the enforcement order, the legal dispute will be transferred ex officio to the competent trial court. Otherwise, the enforcement order becomes legally binding upon expiry of the two-week objection period. You can enforce the enforcement order against the defendant.
